## **Start Smart/Work Smart**

At the Northern District meeting on March 3, Sue Christie, a member of the McLean Branch

AAUW (pictured, right), gave a presentation based on her experiences with Work Smart. Both Start Smart and Work Smart are 2-hour workshops that provide practical help on how to negotiate for higher salaries. The former is for women who are entering the workforce for the first time; the latter is for those already in the workforce who are being promoted, making a lateral move, or changing jobs.

These workshops are a way to provide something unique and worthwhile to people who may not be familiar with AAUW. It's a means of showing them what the organization stands for and can do. Once they learn about the organization, they may choose to join us.

Work Smart workshops are currently being given to women employees in Boston, San Francisco, and Denver city governments; and in Massachusetts state government. The seminars teach negotiation techniques such as how to discuss salary without feeling that you are bragging, but rather that you are presenting data; how to avoid answering the question "what do you make now?"; how to avoid stating what salary you would accept; and how to get information about salaries for comparable jobs with other employers.

AAUW owns the legal rights to both programs. Any group that wishes to conduct these workshops



needs first to identify a host group, such as a university, corporation, or political jurisdiction (e.g., city government). Then they identify a point person in the organization with whom they can make arrangements. The host group signs a 3-year contract with AAUW to lease the curriculum materials. Individuals who have been trained and credentialed by AAUW conduct the workshops.

The consensus of the group on March 3 was that this should be a project for the Northern District, rather than one for a single branch. With three thriving universities in the area (George Mason, Northern Virginia Community College, and Marymount), these institutions might be our best candidates to start with. The district would need to find funding or raise money to finance the effort and provide logistical support. The group

consensus was to establish a core group with someone from each branch to discuss the issues involved in starting this effort. Dottie Joslin and Anita Light have agreed to join this group from our branch. Many thanks to them both.

To access the MSD, go to the AAUW website (<u>www.aauw.org</u>).

- 1. Click LOGIN located at the top of the page next to JOIN. This will open the LOGIN box. Enter your member ID and password. If you do not have a password, you will first need to CREATE AN ACCOUNT. There is a link to provide your member ID if you don't have it.
- 2. Once logged in, scroll down the page to the "About AAUW" menu and select MEMBER SERVICES DATABASE. On The next page, click on Enter Member Services Database.
- 3. Once in the MSD, click on the menu option (near the top) titled "Individual Contributions."
- 4. Find LAF (second line) and enter your contribution amount. Click Next. Verify your gift and click Next again.
- 5. Enter your credit card information and other required information. Verify. Click Submit.
- 6. To EXIT the MSD, click LOGOUT located at the top left of the page. Your donation will be posted to your member account (your MSD page).

If you prefer to donate by check, please make it payable to AAUW Legal Advocacy Fund. Please give or mail it to Dottie Joslin (11110 Del Rio Dr., Fairfax, VA 22030-5339). She will mail the collected checks to AAUW with the AAUW MSD donation form, which credits the branch and individuals (on members' account page) with the donations.

#### **AAUW Dues Increase**

As you are probably aware, the AAUW Board of Directors voted in June 2017 to raise national dues for the first time in a decade, effective March 16, 2018. National dues will now be \$59. As Julia Brown, AAUW Board Chair, said recently on a video emailed to all members, by not having an increase in 10 year, our dues have not even kept up with inflation.

## The website explains:

Annual dues currently account for 13 percent of AAUW's annual budget. They help to sustain and grow AAUW's programs and work that advances equity for women and girls. A combination of dues, donations, and corporate and foundation funding is critical to supporting AAUW's salary negotiation workshops, groundbreaking research, advocacy efforts, campus leadership programs, and so much more.

AAUW wants to keep its focus, maintain relevance, and increase its impact. We all know there is great value in doing so. Julia Brown emphasizes that if we want to realize the impact that women and girls deserve, we must ensure that we have the resources necessary to make real change happen.

As AAUW members we want to participate in realizing this goal through our actions—AND to put our money where our mouth is by proudly renewing our AAUW memberships this spring. We *must* make certain that AAUW has what it needs to change the climate for women and girls.

#### What else is new?

- The half-year dues rate between January and March is being eliminated.
- Paid Life Membership remains at \$980 until March 16, when it goes to \$1,180. Paid Life Membership is fully tax deductible.
- Going forward it is useful to know that new members, who join at a branch program that is open to the public, will receive 50% off the national dues. And for every 2 members gained this way, branches will receive a free membership to give to a person of their choice.
- Give a Grad a Gift (at no cost to you or them!) is still available within 2 years of a student's graduation. Just fill out the form at <a href="https://www.aauw.org/?s=Give+a+grad">https://www.aauw.org/?s=Give+a+grad</a>.

- Shannon Wolfe, managing director and chief of staff, who comes to us from the Brookings Institution with a 20-year career in nonprofit organizations.



#### In Case You Didn't Know . . .

The Clery Act requires colleges and universities that accept federal student aid to maintain and make public statistics on campus crime and security information. Compliance reviews are initiated when the U.S. Department of Education receives complaints, when media reports raise concerns about compliance, or when independent reviews indicate noncompliance. The Department is currently investigating the University of Michigan in connection with its handling of allegations of sexual assault against Larry Nassar, recently convicted of multiple charges of sexual assault while he was employed by the University. #### **VOTE TWICE!**

Yes, it's legal. You will be voting twice this spring in AAUW elections, once for Virginia and once for national. So you won't get them mixed up, here's the info you need.

## **AAUW National Bylaws Amendments**

- Watch for *Outlook* in April with the proposed amendments and your voting number. There are only three, but they are important ones. The first changes the national board structure to staggered 3-year terms. The second allows up to 5 non-AAUW members on the 15-member AAUW Board (non-members could serve as officers of the board, including chair). The last provides opening up membership to all who support AAUW's mission. Members' comments to these amendments are at <a href="www.aauw.org">www.aauw.org</a>; click on bylaws.
- Online voting starts **April 25** and closes **June 9** at 9:00 p.m. ET.

# **AAUW** of Virginia Voting

- The Spring Virginia Vision has the slate of state officers to elect and the proposed 2018–2020 Public Policy Priorities. Any changes to the latter as a result of discussion at the April 20–22 state conference will be emailed to members on April 23.
- Online voting begins **April 24** and concludes on **May 14** at 9:00 p.m.
- Note that there are no paper ballots for Virginia AAUW. Branches are encouraged to provide assistance to members who have no internet access.

**Be sure to vote** on both the state and national ballots. It's critical that we have a quorum of the membership voting and even more important that we exceed the quorum by a large margin.
