We were honored that **Dr. Heather Coltman**, the JMU provost and senior vice president for academic affairs, delivered the keynote address. She is renowned both as a world-class pianist and academician. Dr. Coltman began her remarks with something we know all too well: "There's still a great deal of work to be done until we achieve equity for all." She described how Virginia reflects "what we're seeing on national and international *levels, manifesting those tensions* through over 400 years of history. 1619 gave us the first meeting of the General Assembly in our state. 

### Call for Proposed State Bylaws Amendments and Proposed Resolutions

The Bylaws/Resolutions Committee is issuing a call for proposed amendments to the state bylaws and for proposed resolutions to be presented at the AAUW of Virginia Annual Business Meeting, April 18, 2020, in Alexandria, VA. These will be voted on under the One Member, One Vote procedure.

Please submit bylaws amendments and resolutions by email to Suzanne Rothwell, Bylaws/Resolutions Chair, at https://aauw-va.aauw.net/contact-us/ no later than December 1, 2019.

Proposed bylaws amendments must include a copy of the original section of the bylaws being amended, a markedup version showing the specific wording of the amendment, and a clean version showing the language as it would be revised. The bylaws amendment proposal must include a statement of the rationale for the amendment. Each proposed resolution must include the specific wording of the resolution, a statement of the rationale for the

proposed resolution, and a proposed plan for the implementation of the resolution.

### Proposal to be Voted on to Delete Virginia Half-Price Dues Discount

The AAUW of Virginia Board of Directors, at its July 28, 2019, Board meeting, approved a proposed amendment to the AAUW of Virginia Bylaws to be presented at the AAUW Annual Business Meeting on April 18, 2020, which amendment would delete Virginia's half-price dues discount for new members joining a branch between January 1 and March 15. This change is consistent with the determination by national AAUW to eliminate its January 1 to March 15 half-price dues policy in 2018. The proposed amendment will be voted on under the One Member, One Vote procedure.

Few new members rely on this small discount of \$7.50 from the \$15 state dues. Instead, branches are making available to new members national's **Shape the Future** half-price (\$29.50) discount, which applies through the Leslie and Carol next fiscal year for those that join a branch after March 15th. Please direct any comments or questions on the proposed amendment to the committee chair.

> Following is the proposed amendment with the text struck out that is to be deleted.

### Article XVII. FINANCIAL ADMINISTRATION Section 5. Affiliate Dues.

Amount. \* \* \*

(6) State Affiliate dues of new Members shall be paid upon joining and shall be forwarded immediately to the state Affiliate's vice president for finance. State Affiliate dues received by the vice president for finance between January 1 and March 15 shall be one half the annual dues.

### Non-Substantive/Editorial Changes to the AAUW of Virginia Bylaws

The AAUW of Virginia Board of Directors, at its July 28, 2019, Board meeting approved the following changes to the AAUW of Virginia Bylaws that do not require a vote of the membership because they are editorial in nature. The revised Bylaws are posted to the **AAUW of Virginia** website.

The revisions were made to Article XI, Section 1(b) and Section 3 of the AAUW of Virginia Bylaws to:

- 1. update the list of appointed officer/director positions;
- 2. clarify the historical practice that any new appointed officer positions must be approved by the Board of Directors, whereas the president shall approve a member to an appointed position;

- 3. clarify that only elected officers are limited to two consecutive two-year terms, whereas appointed officers are allowed three consecutive two-year terms; and
- 4. include the Bylaws/Resolutions Chair in the category of appointed officers that are excepted from the term requirement (as is the parliamentarian) in order to retain a member with compliance experience on the Board.

### Public Policy Slow and Steady Wins the Race

Suzanne Rothwell Teachers and students are back in school and election Bylaws/Resolutions Chair season is in full swing. We thank the branches that are



actively **Getting Out the** Vote (GOTV) by registering voters. While progress is being made toward fair, nonpartisan redistricting, many of our districts remain confusing. Make

sure you know who is running to represent you. While we await the outcome of the statewide elections on November 5, we are planning two State Lobby Days – January 15, 2020 and February 12, 2020 – where we will engage with Virginia delegates and senators in Richmond. We plan to host a reception for women legislators the evening of January 14. AAUW-VA is again working with like-minded organizations to make 2020 the year that Virginia ratifies the ERA.

In the coming year we also will be working to educate our elected officials about the very real **gender pay** gap while encouraging them to pursue legislative remedies. There is important new momentum on this issue. In the



previous Vision, we noted the passage of the Paycheck Fairness Act of 2019 in the U.S. House of Representatives. (Still waiting for action from the U.S. Senate.) The Paycheck Fairness Act of 2019 prohibits employers from using salary history, protects against retaliation for discussing pay with colleagues, and ensures equal pay for equal work – measures we would like to see the Virginia legislature embrace. On June 20, Governor Ralph **Northam** announced the implementation of the **Employment Equity Initiative for State Agencies** that eliminates questions about a potential state employee's

### Treasurer's Report



The budget for 2019-2020 was approved with minor changes at the summer 2019 board meeting. The opening checking account balance was \$36,801.35. This

balance includes \$5,243.42 in unspent funds carried over from 2018-19 fiscal year and includes the investment balance. The predicted/budgeted income from dues, investment dividends, checking account interest, and AAUW of Virginia History book sales is \$21,045.44.

The projected disbursements including board meetings, travel, insurance, and newsletters are \$20,839.00. It also includes NCCWSL support of \$2000, and \$1,500 for mini grants to branches for Public Policy projects.

### Virginia State Officers Call for Nominations

Those of us who have served in leadership roles in our branches understand the personal satisfaction and rewards of working as members of a team committed to furthering AAUW's mission and goals. The sense of making a difference on issues we care about is even greater when your experience extends to the level of the state

board and its important role in supporting branches throughout Virginia. Four opportunities for service on the state board are open for 2020-2022.

- President (candidates must have previously served on AAUW of VA Board of Directors)—
   administer all board activities; preside at meetings of the board, executive committee, and
   state; submit forms and reports required by AAUW; ensure AAUW of Virginia Bylaws are up dated; execute all legal documents; select all appointed officers and chairs, except for the
   Nominating Committee; and perform other duties usually pertaining to the office.
- **Vice President for Program**—Chair the Committee on Programs; assume the duties of the president in her absence or inability to serve.
- **Vice President for Public Policy**—Chair the Public Policy Committee; assist the president with public policy issues to meet state and federal needs in accordance with AAUW guidelines.
- **Vice President for Communications**—Chair the Communications Committee, which includes those with responsibilities for the website, other social media, and publication of the *Vision*.
- ⇒ **Commitments:** Attend board meetings (summer, fall, winter conference call, and state conference). Prepare reports for board meetings and the *Vision*.
- ⇒ **Benefits:** \$40/room, hotel reimbursement. \$.30/mile, travel reimbursement. Board meeting meals.

Election Calendar: From October 1 to December 1, 2019, the Nominating Committee will accept submissions from individuals and/or branches. Self-nominations are welcome. Co-officers may be nominated. The term of office for each position is July 1, 2020, to June 30, 2022. Each AAUW of VA member will vote online or by ballot following the 2020 state conference April 17-18. 

In 1983, representatives from national gender equity organizations met because of the need for empowering college women in leadership skills. As a result, the

National Conference for College Women Student Leaders (NCCWSL) was founded, with AAUW in the lead. Since then, over 10,000 women have attended NCCWSL, which has become an essential experience for any woman serious about creating meaningful impact on her campus, mobilizing her community, and preparing for personal and professional success after graduation.



Edidiong Raphael Usoro was one of the NCCWSL attendees who received a scholarship through our donation. She is an AAUW International Fellowship Alumnae who has recently graduated with a master's degree in cancer biology, prevention and control from the University of the District of Columbia. Here's what she wrote us: "I am thrilled to have been selected for this honor and I deeply appreciate your support. You made my attending the conference a possibility and not just a mere dream .... This NCCWSL Conference motivated me to complete my AAUW Work Smart Online Course...I also just registered to be an AAUW national member...as I was inspired to do more and give back to my society. Some of my friends are now in the process of taking the AAUW Work Smart Online Course and becoming AAUW members at the national and branch level. All these wonderful experiences [at NCCWSL] were made possible through your generous funding..."

Greater Richmond Branch member **Cathryn Richmond**, M.A., who is a developmental psychology doctoral student at Virginia Commonwealth University, attended NCCWSL through an AAUW partial scholarship. She describes herself as "incredibly grateful as it was an amazing experience!" One moment that stood out for her

saw the introduction of enslaved Africans and the systemic recruitment of English women to the colony, all in the name of political and economic expedience. Centuries later, we're a commonwealth and a country that's caught in a paradoxical space." One example of the paradox she cited was even though this fall JMU would be "opening a new residence hall for **Paul Jennings**, James Madison's personal manservant," there are three buildings on campus named for Confederate generals. She asked: "How can we reconcile our love of freedom and equality with our history of disenfranchisement and its ongoing effects?" In her answer, she highlighted JMU's Task Force on Inclusion.

Caroline Pickens, AAUW-VA AAUW Funds Chair, demonstrated how our donations to AAUW fund excellent programs that empower women and girls. Caroline interviewed JMU's **Dr. Besi Muhonja**, who was an AAUW 2004-05 International Fellow from Kenya at Binghamton University, State University of New York. She is now coordinator of African, African American and Diaspora Studies and an associate professor of Women's, Gender and Sexuality Studies in the JMU Department of English. In addition to teaching, she is a prolific researcher and author of many books. One of her subjects is **Wangari Maathai**, the first African woman to receive the Nobel Peace Prize, whom she discussed, along with the African philosophy of Ubuntu, i.e. "I am, because you are." She explained that an individual must treat the next human being with humanness because you cannot dehumanize another person without yourself being dehumanized. By the time **Dr. Muhonja** finished, we all wanted to sign up for one of her classes!

The rest of the day featured sessions on diversity, equity, and inclusion; communications; public policy; the Alexandria Branch's human trafficking initiative; public policy; and an AAUW update. Copies of the presentations can be found on our website. Many of those who came the night before the SLM were treated to a tour of the Edith Carrier Arboretum by certified naturalists, including Harrisonburg Branch member **Pam Gier**.

### Help the Library of Congress Preserve Women's History - Suffrage: Women Who Shaped History

The **Library of Congress**, through their **By the People crowdsourcing platform**, offers a unique opportunity for the public – YOU – to take an important part in celebrating the 100<sup>th</sup> anniversary of the 19<sup>th</sup> Amendment. **It is asking for assistance in transcribing nearly 16,000 collected historic papers related to the women's rights movement.** 

These papers include the personal papers of well-known suffragists, such as **Susan B. Anthony** and **Mary Church Terrell**, as well as those of **Anna E. Dickinson** and other lesser known women. It is inspiring to transcribe, word for word, the letter written in beautiful longhand by **Carrie Chapman Catt**, to a member of the clergy, in which she expresses her objection to a woman's promise to obey her husband in the marriage vows. Special thanks to **Branch President Carolyn Hughes** and Newport News Branch members for their great work in planning for the meeting. They have done an excellent job!






### 100K for Equal Pay - DONE!

### **HUMAN TRAFFICKING**

Human trafficking is a \$163 billion industry globally with up to 40 million slaves worldwide. Virginia is number six in active cases and number 15 in notifications. The main trafficking areas are along I-95, I-81, Richmond, the beach areas, and in the areas surrounding Washington, DC. **AAUW of Alexandria** presented at the Summer Leadership Meeting a three-pronged approach to combat human trafficking with educational awareness, advocacy, and research and development (R&D). The R&D arm will be the **AAUW Angel App**. This app will have three buttons for people silently to use to contact 911, a trained investigator, and/or report any warning signs of human trafficking to the authorities. The **Angel App** can start an **Angel Alert**. If it is an emergency, an emergency button will alert 911 to the victim's emergency and start a tracker on their phone. If it is



not an emergency, but the person needs help, there will be another button for non-emergencies which the person can hit to send information to a trained investigator and/or start the tracker. The third button will be a reporting button for concerned citizens to report a case and/or warning signs that they have encountered to the authorities. This program will be piloted in Alexandria, then throughout Virginia, and then the United States.

At the SLM, Alexandria Branch leaders requested Virginia provide branch support for the Angel App. The Alexandria Branch will apply for grants this fall and next spring; and wishes to list that Virginia branches support this initiative. AAUW Community Action grant is currently being written. ### How to Celebrate Women's Vote Centennial

The women's suffrage movement began in 1848 when a women's rights convention was held in Seneca

Falls, New York. This meeting was not the first to support women's rights, but suffragists later viewed it as the launching of the suffrage movement. They felt that being able to vote was key to women's rights. Women across the U.S. protested, were imprisoned, and lobbied Congress in their efforts to win the right to vote. After decades of arguments for and against women's suffrage, Congress passed the 19<sup>th</sup> Amendment to the Constitution in June 1919. When 36 states had ratified the Amendment, on August 26, 1920, Secretary of State Bainbridge Colby certified that the 19<sup>th</sup> Amendment had become a part of the Constitution. It has been called the single largest extension of democratic voting rights in our nation's history.

As your branch makes plans to celebrate the 100<sup>th</sup> anniversary of women's suffrage, please share that information across the state. Send a brief description of plans, activities or collaborations to **Patsy Quick**, Vice President for Communications. She will post it on the state webpage. If you send photos, please identify folks shown. Here are some suggestions and resources for your use.

#### Suggested activities for branch celebrations:

- Provide speakers in schools
- Hold an event or start a series in a public library or historical society

- \* Push for legislation and proclamations
- Plan a July 4th parade or a reenactment of a significant women's history event
- \* Collaborate with local colleges and universities, League of Women Voters, and other women's groups
