Recognizing the risks and opportunities of this election, AAUW-VA members have stepped up to help ensure that voters go to the polls and that when they get there, they understand how candidates stand on our public policy priorities.

The criteria for these nominations are as follows:



The recipient cannot be a current state board member or a person seeking elective political office in the year when the award is presented at the state conference. Detailed information must be presented with a nomination that substantiates the contribution and service of the nominee.

The nominations deadline is November 17, 2023. You are welcome to update and re-submit nominations from 2022. The committee reviews all nominations and may recommend to the state board a nominee for each \$500 contributed to AAUW funds by the AAUW of Virginia state affiliate. ### Call for Bylaws Amendments and Proposed Resolutions

The AAUW of Virginia Bylaws and Resolutions Committee is issuing a call to all AAUW Virginia members for proposed amendments to the state bylaws and for proposed resolutions to be presented at the AAUW of Virginia Annual Business Meeting to be held in 2024.

BYLAWS

These will be voted on under the One Member, One Vote procedure. **Please submit bylaws amendments and resolutions to the Committee Chair by e-mail no later than December 1, 2023**, using the contact information provided on the AAUW-VA webpage: <u>https://aauw-va.aauw.net/contact-us/</u>.

A proposed bylaws amendment must include a copy of the original section of the bylaws being amended, a markedup version showing the specific wording of the amendment, and a clean version showing the language as it would be revised. The bylaws amendment proposal must include a statement of the rationale for the amendment. I am available to assist any member not familiar with the mark-up function of their computer (also called red-lining). See the AAUW of Virginia Bylaws at <u>https://aauw-va.aauw.net/library/</u>

**A proposed resolution** must include the specific wording of the resolution, a statement of the rationale for the proposed resolution, and a proposed plan for the implementation of the resolution. You may wish to review Article XVII, Section 6 of the AAUW of Virginia Bylaws about the resolution process.

### Reminders of IRS and Bylaws Matters



**IRS Form 990**-**N**—Please go to page 10 of the Summer *Vision* (on the AAUW-VA website) for directions on how to make your branch's annual mandatory submission to AAUW of information needed for AAUW to submit the 2023 IRS Form 990-N to the IRS on behalf of your branch by October 15, 2023.

**Update Branch Bylaws**—See my email to branch presidents and bylaws chairs of July 5, 2023, with directions on how branches should update their bylaws by replacing the first seven articles with the 2023 AAUW Affiliate Model Bylaws text that is published by AAUW at <u>BYLAWS</u>.

Affiliates are required to make these bylaw changes by June 30, 2026.

Congratulations to Laura Zarrugh, Harrisonburg Branch president, for being the first branch in Virginia to update its bylaws!

**Branch Bylaw Changes and Governance Issues** – Except for the 2023 AAUW Affiliate Model Bylaws, branches are required to contact me to discuss any other proposed changes to their branch bylaws before approval by the branch board and members so that I have an opportunity to provide advice on such changes. We're about a quarter of the way through our fiscal year, so here's an update on our budget.

We're running behind on our income. We projected \$13,500 for dues. As of September 28, we've received \$6,145, which includes a deposit of \$660 from AAUW that was still pending as of September 28th. Renewal dues are now payable on the renewal anniversary date for each member so we should expect to see deposits throughout the year.

The major expense category as of September 28 is Public Policy/GOTV. The actual for GOTV is \$562.42 versus a budget of \$1,000. We also reimbursed a board member for mileage for a conference planning trip from board travel. The Board may want to consider a separate mileage line item for conference planning to more accurately reflect costs for the Conference.

If I'm doing my math correctly, our checking account balance as of September 28, should be \$43,000.67, which again includes the \$660 pending deposit from AAUW. There are two outstanding checks. See below for the reconciling calculation.

\$43,000.67 - 87.72 (GOTV) -64.00 (mileage for Conf planning) = \$42,848.95.

### Don't Forget: Bylaws Changes

### The Mandatory Bylaws Changes

In spring 2023, AAUW members voted by more than a two-thirds to approve amendments to the AAUW Bylaws. The AAUW Bylaws amendments require that state and branch affiliates make mandatory conforming changes to the first seven articles of their bylaws, which should be completed by June 30, 2026. Changes to affiliate bylaws that are mandated by AAUW do not require branch board or membership approval.

Updated information about this bylaws revision was provided by **Suzanne Rothwell**, **AAUW-VA Bylaws and Resolutions Chair**, on September 29, via email. The email included a copy of the 2023 AAUW Affiliate Model Bylaws document in Word and other important information.

- Vice President for Program (two-year term): Assume the duties of the president in her absence or inability to serve and coordinate with the president and conference chair in the planning of the AAUW-VA State Conference and other state membership meetings and programs.
- Vice President for Public Policy (two-year term): Develop and implement plans for state and federal advocacy efforts that meet state and AAUW priorities in coordination with the president and per AAUW guidelines.
- Vice President for Communications (two-year term): Chair the Communications Committee, which includes those with responsibilities for the website, other social media, and publication of the *Vision;* and provide communications guidance and information to the branches for newsletters and other activities.

#### **Responsibilities include:**

- Attending board meetings four times a year, on Zoom or in person, and attending the state conference and annual business meeting.
- Preparing reports for board meetings, the Vision, and the annual business meeting.

The **Alexandria Branch** had an exciting summer. The final meeting and get-together last year was in June at Fratelli's for brunch. Always active, members worked on postcards over the summer. Members sent postcards urging people to vote in the primaries and will remind people to vote before and on Nov. 7. The branch donated backpacks to Women Giving Back and school supplies to Community Lodgings for homeless students. The mystery book club, French club, and Gourmet Out Club met during the summer. Members had social get-togethers at the Turkish Coffee Lady's restaurant and also attended a movie. The 2023-2024 year started with a fascinating talk by Mayor Justin Wilson about the status of Alexandria.

In June, the Fairfax City Branch held its 50<sup>th</sup> anniversary luncheon. The Arlington Branch has planned a series of inperson activities that promise to be of great interest to members. The presentation included a brief overview of Generative AI, which refers to AI systems that can generate new and unique content, such as images, music, and text. The overview described Chat GBT, a type of generative AI, and how it works, using examples that create superheroes and how they are used in applications such as storytelling and character design.

In October, Katherine Spivey will present information about the Plain Language and Information Network, a global effort to make communication more understandable and accessible. In November, the branch will have a book talk on Kathy Kleiman's book, "Proving Ground: The Untold Story of the Six Women Who Programmed the World's First Modern Computer." In early December, the branch will have a holiday luncheon at a local restaurant followed by a field trip to a local bookstore to get expert advice on holiday gift selections for families and friends. This year, the fall monthly book club discussions include "Lessons in Chemistry, The Dictionary of Lost Words," and "Dinners with Ruth: A Memoir on the Power of Friendships." In September, the branch introduced the mentorship Lunch Bunch program to a new group of Arlington High School senior girls. The branch will also partner again with the Arlington and Alexandria League of Women Voters in sponsoring two candidate forums in October.

Falls Church Area Branch kicked off 2023-2024 with a meet and greet of new and returning members. The branch started with Arina van Breda from The League Of Women Voters sharing her experiences with registering voters after naturalization ceremonies. She provided information on how to be certified to register these new citizens to vote and witness their first steps to becoming fully involved new citizens. The branch will continue its tradition of participating in the Reclaim Our Vote (ROV) postcard writing campaign. The ROV cards urge VA voters to consider where the candidates stand on important AAUW issues: reproductive rights and freedoms, voting rights, access to jobs, and education.

To raise money for the scholarship fund, two fundraisers are in the works. First is a partnership with BloomBox, a local online garden center that sells fall plants and more, and second, the branch returns to the Falls Church Festival with a used jewelry and accessories sale. 15% of Bloom-Box purchases and 100% of the jewelry sales will go to the fund for local high school scholarships.


