# National Inventors Hall of Fame Museum April 6, 2024, 12:00 p.m.-1:30 p.m.

If someone asked you where the Baseball Hall of Fame is, you'd probably know it's in Cooperstown, New York. What if someone asked you where the National Inventors Hall of Fame Museum is? Would you be able to tell them it's in Alexandria, Virginia?

- "The National Inventors Hall of Fame was founded in 1973, and its museum was moved in 2008 to the campus of the United States Patent and Trademark Office in Alexandria, Virginia. The museum is run by the nonprofit **National Inventors Hall of Fame** in partnership with the USPTO."
- "The mission of the National Inventors Hall of Fame<sup>®</sup> is to recognize inventors, promote creativity, and advance the spirit of innovation and entrepreneurship."

Come join us at the National Inventors Hall of Fame Museum, located at 600 Dulany Street, Alexandria, for a museum tour, followed by a presentation about the museum's STEM programming for K-12 and college students.

The museum exhibits showcase U.S. patent holders, and include "Women in Innovation," "Breaking Barriers: Honoring Extraordinary Black Inventors," and "Champions of Innovation"— "the team of inventors behind the revolutionary Jogbra<sup>®</sup>: the world's first sports bra."

#### HUMAN TRAFFICKING FORUM

The Anti-Human Trafficking Team of the Alexandria branch invite you to learn about forced labor from Evelyn Chumbow and Erica Reid.



**Evelyn Chumbow** is a survivor of child labor trafficking turned anti-trafficking activist and public speaker who has focused her life's work on ending modern-day slavery, a crime impacting some 40 million victims globally.

Ms. Chumbow was brought to the United States from Cameroon at the age of nine and forced to cook, clean, and care for her trafficker's children. She was never paid for her work, and any hope that she might escape was undermined by the constant beatings she received from her trafficker.

After years of captivity, she finally escaped and her trafficker was sentenced to 17 years in prison. Today, Ms. Chumbow works tirelessly to raise awareness and advocate for other survivors.



**Ms. Erica Reid** is a Senior Engagement Manager at the U.S. Department of Homeland Security Center Countering Human Trafficking, Blue Campaign Office with over 18 years of government service. Specializing in public affairs and outreach, Erica uses her experience to raise awareness of human trafficking across the country. Within the Blue Campaign, her portfolio includes educating on the front-end to deter criminal activity and educate communities on how to recognize and report/respond to possible cases of human trafficking. Her portfolio focuses on youth and student leaders, adults working with youth, Native American/Tribal Nations, and Historically Black Colleges and Universities.

Erica has presented to over 5000 persons on human trafficking since joining the Blue Campaign office in 2022.

## Branch Members Serve as Raters for the Scholarship Fund of Alexandria

Since AAUW's founding in 1881, a major focus of our organization has been to advance educational equity for women and girls. This is highlighted in our current public policy priorities by our support for "... a strong system of public education that promotes gender fairness, equity, diversity and inclusivity, and to address the barriers and implicit biases that hinder the advancement of women and girls."

In order to further this mission-critical area, during the weekend of March 1, 2024, three members of our branch served as raters for applications submitted to the Scholarship Fund of Alexandria: Mary Ann Bier, Solveig Eggerz, and Leslie Tourigny.

"The Scholarship Fund of Alexandria, a 501(c)(3) organization, was established in 1986 by concerned citizens to help academically qualified students with financial need from Alexandria City Public Schools afford postsecondary education. Through its relationship with the community, the mission of The Scholarship Fund of Alexandria is to encourage and assist the students of Alexandria City Public Schools by providing them with necessary resources to access and complete a college, technical or career program of postsecondary education.

"In 1986, when it all began, the SFA awarded just over \$7k in scholarships to eight students. Last year alone, we awarded \$1.4 million to support 400+ Alexandria City High School graduates to over 60 different institutions. Ninety-five cents of every dollar raised goes directly to support scholarships. The SFA has awarded over 18 million dollars in scholarships and helped send more than 5,000 Alexandria students with financial need to college since 1986....College advising is the vital resource the Scholarship Fund of Alexandria provides to assist each senior in creating a plan for the future."

Each application is rated by three different raters, and an average score is determined. Kudos to our branch members for volunteering to help in this important community service.

# **PUBLIC POLICY**

#### Virginia Kress, Public Policy Chair

On the National front, the revised **Title IX** regulations that AAUW strongly supports are expected to be released soon. We expect the new rules to reestablish strong protections for students experiencing sexual harassment, strengthen supports for pregnant and parenting students, and clarify that all students, including LGBTQ+ students, have the right to a safe and inclusive learning environment. AAUW's Lobby Corps advocated for these regulations this week.

We're expecting congressional challenges when the rule is finalized, so members of Congress need to understand reasons to support Title IX. <u>Please tell your members of Congress that you</u> <u>support a robust Title IX rule that supports and protects ALL students.</u>



#### Save the date: AAUW-VA Public Policy Meeting April 9 at 6PM by Zoom

Overall, it's been a very positive legislative session for our priorities.

Five important bills were approved by the General Assembly and sent to the Governor on a fast-track basis. Here's the results:

- HB 894 Expanding public meeting electronic access SIGNED BY THE GOVERNOR
- SB35 Requiring unconscious bias training for medical providers The Governor asked for an amendment
- SB238 Mandating insurance coverage of contraceptives Governor asked for an amendment
- SB101 Marriage equality SIGNED BY THE GOVERNOR!
- SB235 Creating controls on school district book bans Vetoed by the Governor

Virtual Lobby Day was a success. Forty members participated in the morning Zoom rally and then went out to contact their Delegates, Senators, and the Governor. We hope our advocacy will help encourage the Governor to sign legislation on out Public Policy Priorities. Again, thanks to AAUW National for all their support on the Action Alerts.

AAUW National has announced an exciting program to engage states and branches in getting out the vote for the November 2024 election with It's My Vote. You can find some really great resources here, including an overview of the program, <u>https://www.aauwaction.org/my-vote/</u> There will be a series of programs on important issues also available on that website. Details of what we will be doing in Virginia will follow. As the webinar pointed out, nothing is more critical to our policy priorities than the outcome

of this election. Participation in the leadership of the program statewide and strong participation on the branch level will be vital in this work.

The state public policy meeting provided important updates on what is happening at the National level:

- ERA: National PP is focusing with our allies on what actions would be most strategic and are focusing on discharge petition. They believe the "Sign for ERA" movement is not the best option.
- UN Status of Women: Gloria will be speaking at the UN on the ERA. AAUW has permanent observer status at the UN. - Salary History Ban: The proposed rule to ban salary history use by Federal contractors is progressing.
- College Cost Reduction Act: AAUW has mixed feelings about the "College Cost Reduction Act" which would expand Pell Grants to short-term certificate programs as currently proposed because it does not have enough controls over schools that have poor student outcomes.
- Title IX: Although AAUW is pleased with the current proposed rules on most Title IX protections, the proposal does still not deal with transgender students in sports.
- Equal Pay Day: The Equal Pay Day Calendar for 2024 has been released<u>https://www.aauw.org/resources/article/equal-pay-day-calendar/</u>. All Women's Equal Pay Day is March 12. National has a great new tool to help members write op-eds or letters to the editor of their local papers <u>https://www.aauw.org/resources/policy/advocacy-toolkit/lte-vs-oped/</u>
