President's Message

December 10 is recognized as International Human Rights Day. The universal declaration of human rights was first celebrated on this day in 1948 by the United Nations general assembly in Paris. This document has been translated into 577 different languages, the most translated document in the world. It promises that everyone is born with the same inalienable rights without regard to a person's race, color, religion, or gender. Yet 76 years later, in the 21st century, we are still trying to guarantee these fundamental rights to all American citizens.



As you know, in 1881, AAUW was founded by like-minded women to recognize and celebrate their tenacity in achieving the goal of obtaining a university degree.

Access to higher education had long been denied to women. Their mission was to help other women in their pursuit of not only furthering education, but to make inroads into traditionally male dominated careers.

If you attended Spring Fling two years ago, our speaker was Coline Jenkins, the great-great granddaughter of Suffragist, Elizabeth Cady Stanton. She spoke to us about the women in her family. Her mother was an architect, and her grandmother became a civil engineer. Her discussion included details of how these women fought to work in their chosen careers and to participate in professional societies that support these professions.

AAUW and other groups, as well as our public schools have supported STEM. The intent is to interest and educate young women to work in science and math fields. Some of you may have read books about Albert Einstein's first wife, Mileva Maric, who was also a physicist and some authors believe that she contributed greatly to Einstein's research and theories. A recent film, "Hidden Figures," opened our eyes to the lives of three African-American women mathematicians who contributed greatly to the success of America's early entry into the Space Race.

Our November speaker was Eileen Filler-Corn. She was the first woman in the 400 years of Virginia's legislature to serve as speaker. She has served on many committees and boards that support the Commonwealth as well as being one of the organizers of the Million Mom March.

One of the most important goals of AAUW is to ensure equal pay for equal work. On October 12, 2024, we lost activist Lilly Ledbetter who died at the age of 86. She was the plaintiff in the case of Ledbetter vs. Goodyear Tire and Rubber. Due to sex discrimination, she missed out on raises given to male employees doing the same work. She estimated that over the course of her employment with Goodyear she had lost out on approximately \$200,000. This case resulted in the passage of the Lilly Ledbetter Fair Pay Act of 2009 by Congress. She continued to lobby for equality during her lifetime and was entered into the National Women's Hall of Fame in 2011. AAUW honors her legacy by supporting legislation such as the Paycheck Fairness Act.

Deepa Patel, our featured speaker, is the Co-Founder of Trauma and Hope, a private government contracted mental health organization dedicated to supporting survivors of trauma including violence, sexual exploitation, and gang involvement.

A Licensed Clinical Social Worker and Certified Sex Offender Treatment Provider, Ms. Patel specializes in trauma-focused mental health care, offering expertise in working with non-voluntary court mandated clients, including gang members and perpetrators of sex crimes. She is proficient in various therapeutic modalities such as Eye Movement Desensitization Reprocessing (EMDR), Cognitive Behavioral Therapy (CBT), Progressive Counting (PC), Dialectical Behavioral Therapy (DBT), and Havening, which she uses to address developmental and complex trauma.



Deepa Patel

With over two decades of experience, Ms. Patel has developed a 5-day human trafficking program for professionals working with survivors of human trafficking, Sexual Exploitation Treatment and Training Services (SETTS). Her programs, rooted in evidence-based practices, have been implemented statewide in Virginia in partnership with the Virginia Department of Criminal Justice Services.

Ms. Patel is a sought-after consultant and trainer in trauma, human trafficking, and gang intervention. Her work has earned her numerous awards, including the Virginia NASW Social Worker of the Year Award (20117) and the Frederick Milton Thrasher Award for gang intervention. She continues to shape policy and practice at local and national levels, providing critical education and interventions.

Public Policy

As you know, AAUW and AAUW-VA are solidly non-partisan and our public policy priorities reflect issues and policies that are not, and should not, be partisan. Our job throughout has been to persuade legislators on both sides of the aisle – in Richmond and on the Hill – of the benefits to the economic security of women and families if these priorities are translated into legislation. That's what we are about: AAUW – Empowering Women Since 1881! Refer to the letter at the end of this newsletter from AAUW's CEO, Gloria Blackwell, sent to all members after the recent election.

Why the Wage Gap Just Got Worse and How to Close It

The problem: The gender wage gap in the U.S. widened in 2023 for the first time in two decades, with women earning 83 cents for every dollar men make.

Why it matters: The stall in progress is driven by caregiving burdens, a concentration of women in lowwage jobs, and complex social factors, according to AAUW CEO Gloria L. Blackwell.

Alexandria's Great Decisions Group

The Great Decisions program, organized by the Foreign Policy Association (FPA), is a nationwide initiative aimed at engaging Americans in discussions about key foreign policy issues. It serves as a platform to raise awareness and deepen understanding of global issues that directly impact U.S. foreign policy, security, and international relations.

Great Decisions provides a structured, non-partisan, and accessible approach to learning about international relations. Each year, participants study and discuss a set of eight current and critical foreign policy topics that reflect challenges facing the U.S. These discussions are typically guided by a briefing book, facilitated by a group member, and sometimes feature guest speakers.

To facilitate these discussions, the FPA provides a range of resources, including:

- A briefing book that provides in-depth analysis of the selected foreign policy topics.
- Discussion guides to help structure conversations and ensure that key issues are covered.
- Video and multimedia content that sometimes features expert opinions, analyses, and interviews.

The Great Decisions program has grown to include thousands of groups across the United States, involving tens of thousands of participants. It is one of the largest and most enduring public diplomacy and education programs in the country.

The AAUW-Alexandria Branch Great Decisions group began meeting in 2018. Originally, we met in person, and now we meet via Zoom to accommodate participants and guest speakers from all over our area. Typically, we meet eight times annually – on the second Thursday of the month from 7:00 P.M. - 8:00 P.M.

Lobby Corps members have made tens of thousands of in-person visits to congressional offices on issues including reproductive rights, paid family leave, Title IX, pay equity, and the Equal Rights Amendment. Lobby Corps is a commitment of only one morning a month. We generally meet on Capitol Hill on the third Thursday of each month when Congress is in session. Volunteers receive in-depth information about the issue selected and are paired with experienced Lobby Corps members for office visits.
