AAUW-VA's mini-grant program continued to support branch projects that align with our public policy priorities throughout the Commonwealth. The State Board approved \$3,000 for 2025-2026 mini-grants, and emails were sent to all branches, a session was held at the annual conference in Alexandria to provide information for applying online.

Applications were due by September 30, 2025. The Mini-Grant Committee assessed the eight (8) applications based on:

- Support of AAUW priorities

- Financial need
- Value of outcomes

- Lynchburg Leadership supplies

We must complete our project by June 30, 2026, provide a short report at the completion of our activity, and submit all receipts for reimbursement by July 15, 2026. We thank all those who were involved in getting the minigrant for our Winchester Branch. We are in the process of ordering the "recruitment" materials and will be happy to share them with everyone once they arrive.
