## From the President...

And here's an exciting milestone—70% of attendees paid electronically this year, making our registration process smoother, faster, and more secure than ever!


## January 21 at 7 p.m. via Zoom

# **Remembering Judy Baldwin**

The Springfield-Annandale Branch of AAUW mourns the passing of Judy Baldwin, a dedicated leader, historian, and cherished friend whose commitment to our mission spanned decades. Judy contributed significantly to our branch's written history, serving as a key contributor to A History of the Springfield-Annandale Branch, AAUW of Virginia, 1955–2005. Her leadership touched nearly every corner of our work: she served multiple terms as Branch President (2008–2009, 2017–2018, 2019–2020), as Membership Vice President, Diversity Chair, Secretary, Historian, Webmaster, Bylaws Chair, and a guiding force in the 5-Star Program. Recognized as an AAUW Funds Honoree in 2014, Judy's steady presence, historical knowledge, and passion for equity enriched our branch and inspired all who worked alongside her.



Judy's life reflected the same commitment to service, learning, and community that she brought to AAUW. Born in Bonne Terre, Missouri, on April 1, 1939, she embraced her April Fool's Day birthday with joy and humor. A gifted journalist from an early age, she served as managing editor of her high school paper before earning both her bachelor's and master's degrees from the University of Missouri School of Journalism. Her life's journey included Navy travels with her husband Rick, raising four children, and a long career with the Girl Scout Council of the Nation's Capital, where she founded and later co-directed Camp Firefly, impacting generations of young people. A devoted volunteer, sorority alumna, Girl Scout leader, and docent at the Sully Historic Site, Judy gave endlessly of her time and talents. She leaves behind a legacy of service, leadership, laughter, and deep compassion. Her AAUW family will miss her dearly.



## **Getting Out the Vote -- Your Vote is Your Voice!**

This year, ROV targeted 90,000 Black voters in Virginia. **Your efforts did make a difference!** 

The following is the report from Andrea Miller, leader of Center for Common Ground which sponsors ROV: **Virginia just witnessed its second-highest voter turnout ever in a gubernatorial election.** This election shattered early voting records for a Virginia gubernatorial race. ## AAUW's Position on the Decision to Dismantle the Department of Education:

The Trump administration has taken another major step toward dismantling the U.S. Department of Education. Following deep staff cuts, the Department's November 18 announcement of six new "partnerships" shifts the day-to-day work of core K–12 and higher education programs to agencies focused on labor, health, public lands, and foreign policy. This undermines the Department's ability to enforce civil rights laws and ensure equal educational opportunity." Read AAUW's statement here.

Paid Family and Medical Leave has been a long-time AAUW-VA public policy priority. Our members have lobbied legislators on the Hill and in Richmond to expand the current policy (the Family Act) that provides for unpaid leave for family/personal reasons. Many people cannot afford to take extended leave to care for a sick child or family member which is the rationale behind PFML. The recent November election has brightened prospects that legislation on PFML will be passed (for the third time) in the upcoming VA General Assembly session, but this time will be signed by the Governor. In addition to AAUW-VA's regular lobbying, our State President Lane Stone recently signed on to a letter sponsored by the organization Voices for Virginia's Children encouraging the VA General Assembly and the incoming Spanberger gubernatorial administration to pass and sign legislation in the 2026 GA session to establish a statewide PFML program. I will provide points on this issue to branch members to use in written communications with your state delegate and senator.
